Terms & Conditions of Service

General

Baetes Technologies AB, a company registered at Box 92138, 120 08 Stockholm, Sweden, with the Swedish company organizational number (Org. nr 559075-6483) (“we” and “us”), owns and operates the Baetes Platform and Technical Solutions, including the service known as “View at Home”, which allows customers (“you”) to:

1. Generate three-dimensional models of artworks,
2. Showcase generated artworks in their own environment through our web-based View at Home solution as standalone URL-links or as embedded URL-links to your web-pages or other web systems, using the View at Home web application or one of the View at Home formats available,

and use any additional Baetes Platform features (“Service”) that are available at any given time according to the prices and service plans that are provided to you as our client.

In addition, Baetes can provide additional services (“View at Home Creation Service”) where Baetes creates suitable models of your artwork(s) to a separately agreed price.

By using the Services or the View at Home Creation Service, you accept the terms and conditions set out in these Terms & Conditions of Service Agreement.

Use of Service

We provide you a non-exclusive right to use the Service for commercial purposes. The Service is described in the service descriptions available at our website from time to time.

We will make our best effort to keep the Service available on a 24/7/365 basis. However, we make no warranties and hereby disclaim any liability in respect of the availability or functioning of the Service. We may suspend access to the Service at any time for reasons relating to data protection, service maintenance or development, service misuse or similar valid reasons. We make no warranties and hereby disclaim any liability in respect of any accuracy of generated content or any View at Home links including but not limited to compatibility of devices or mobile operating software.

Please keep your user credentials safe. You are responsible for any use of the Service

through your user credentials.

Subscription Period, Service Fees and Payments

We offer both monthly and annual subscriptions for the Service. You can manage your subscription by contacting legal@baetes.com.

The applicable service fee will be due and payable at the beginning of each subscription period. The price of the Service depends on the selected service plan. All prices shown exclude VAT, which will be added to the invoiced amounts if relevant.

If you wish to purchase additional services from Baetes or if you exceed the limits related to a chosen service plan, we are entitled to charge you for these additional services (or an additional service tier) in accordance with the price list.

Intellectual Property Rights

We grant you a limited, non-exclusive, non-sub-licensable and non-transferrable license to use the Service as it is provided to you, as set forth in these Terms & Conditions of Service Agreement.

Personal Data

We process personal data of our customers in accordance with our Privacy Policy. We do not read, use or store any data from websites embedding the View at Home Viewer without explicit authorization of the website owner. You and the website owner are liable for your websites and their collection and processing of personal data.

Confidentiality

We will keep all your confidential information confidential. Confidential information means any non-public information that is provided to us in connection with your use of the Service or the View at Home Creation Service, including your CAD-files.

We will use confidential information only for the purposes of providing the Service and confidential information shall not be disclosed to third parties unless and to the extent necessary for the purposes of delivering the Service. In all cases we shall ensure that such third parties are subject to appropriate confidentiality obligations in respect of your confidential information.

Client Data Provision

To enable us to deliver the Service, you agree to provide us with the necessary artwork image files, product images, and accurate size dimension data of the objects you wish to display using our Service. Without such data, we cannot process or deliver the Service. You confirm that you have the necessary rights, permissions, and licenses to provide such data to us for the purpose of rendering the Service.

Promotional Use of Generated Content

By accepting these Terms & Conditions of Service, you grant us a limited, non-exclusive, royalty-free right to use any View at Home visualizations or generated content created through the Service for promotional, marketing, and demonstrational purposes. This includes, but is not limited to, showcasing the Service in person, on our website, over the internet, through social media, or in any other venue where we may reasonably demonstrate the functionality of the Service. Such use will be solely for the purpose of promoting and demonstrating how the Service works and will not include resale of your content.

Term and Termination

You have the right to use the Service for the applicable subscription period. However, we may terminate your user account and the right to use the Service with or without notice, if we believe that your use of the Service violates these Terms & Conditions of Service Agreement.

Limitation of Liability

The Service is provided on an “as is” and “as available” basis and we disclaim any liability for its functioning or uninterrupted availability. We are not liable for any indirect or consequential damages. We are not liable for any limitations or omissions of services and will therefore not accept any form of refund whatsoever under any circumstances.

Governing Law

These Terms & Conditions of Service Agreement shall be governed by the laws of Sweden without regard to its principles on conflict of laws. All disputes regarding these Terms & Conditions of Service Agreement or the Services shall, at first place, be solved in good faith negotiations between you and us. If a resolution is not reached through these negotiations, the dispute shall be finally settled in arbitration in accordance with the arbitration rules of the Swedish Chamber of Commerce. The number of arbitrators is one and the seat of arbitration is Stockholm. The language used in the arbitration proceeding shall be English.

Miscellaneous

If any provision of these Terms & Conditions of Service Agreement is found invalid or unenforceable by a competent court, the remaining part of the Terms & Conditions of Service Agreement will remain in full force and effect.

We may update and amend these Terms & Conditions of Service Agreement from time to time. We will inform you of any material changes but encourage you to review these Terms & Conditions of Service Agreement regularly.
